

# THE ANTICHRIST COMETH: 2030

In the context of the current pandemic, we see a push toward a cashless society, global identification, and global governance—all under the mask of health and safety. These measures align with the World Economic Forum’s narrative of using the crisis as an opportunity for a ‘Great Reset,’ setting the stage for the Antichrist’s rule. It is crucial to discern the true motives behind such initiatives, as they may serve agendas beyond the immediate health crisis.
